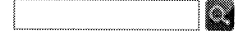

SSM OBTAINS CONVICTION AGAINST A COMPANY DIRECTOR FOR MAKING A FALSE STATEMENT TO THE REGISTRAR

Ong Chin Hoe, the director of Spring Court Sdn Bhd was convicted with an offence under section 364(2) Companies Act 1965 ('CA 1965') after pleading guilty to a charge for making a false statement in relation to the application to strike off Spring Court Sdn Bhd under Section 308(1) of the CA 1965.

Ong was fined RM40,000.00 in default eight (8) months imprisonment. Section 364 (2) CA 1965 provides a maximum penalty of ten years imprisonment or a fine of RM250,000.00 or both.

Earlier the Sessions Court Judge ruled that the Prosecution has made out a prima facie case against Ong and had ordered Ong to enter his defence with respect to the charge under section 364(2) CA 1965.

Mr. Steve Chin Yun Cheong, SSM's prosecuting officer prosecuted on behalf of the Public Prosecutor.

SSM MEMPEROLEHI SABITAN TERHADAP PENGARAH SYARIKAT BAGI KESALAHAN DI BAWAH SEKSYEN 364(2) AKTA SYARIKAT 1965

Ong Chin Hoe, pengarah syarikat Spring Court Sdn Bhd telah disabitkan dengan kesalahan di bawah seksyen 364(2) Akta Syarikat 1965 ('AS 1965') setelah beliau mengaku salah berhubung satu pertuduhan membuat pernyataan palsu berkaitan dengan permohonan penutupan syarikat di bawah seksyen 308(1) AS 1965.

Mahkamah Sesyen Jenayah Kuala Lumpur telah menjatuhkan hukuman denda sebanyak RM40,000.00 dan jika gagal bayar lapan (8) bulan penjara. Hukuman yang diperuntukan bagi kesalahan di bawah seksyen 364 (2) AS 1965 ialah hukuman penjara tidak melebihi 10 tahun atau denda tidak melebihi RM250,000.00 atau keduanya sekali.

Sebelum ini Hakim Mahkamah Sesyen telah memutuskan pendakwaan telah berjaya membuktikan satu kes prima facie terhadap Ong dan beliau telah diarahkan untuk membela diri.

Pendakwaan dijalankan oleh En. Steve Chin Yun Cheong, pegawai pendakwa daripada SSM.
