SSM OBTAINS CONVICTION AGAINST THE DIRECTORS OF GOOD DECADE SDN BHD FOR COMMITTING NON COMPLIANCE OFFENCES UNDER THE COMPANIES ACT 1965

The directors of Good Decade Sdn. Bhd, Liaw Yen Ha dan Ho Kam Leong @ Hoo Yen Pat had pleaded guilty in the Kuala Lumpur Session Court today for committing offences under sections 143 (1), 165 (4), dan 169(1) of the Companies Act 1965.

In the same proceeding, Ho Kam Leong who is the director of Good Decade Sdn Bhd pleaded guilty on behalf of the company for contravening sections 143(1) and 165(4) Companies Act 1965.

The Kuala Lumpur Session Court judge, Puan Rihaida binti Rafei meted out the following sentence:

1. Liaw Yen Ha Ho Kam Leong	<ul style="list-style-type: none"> • S.143(1) – fined of RM500 in default 7 days imprisonment • S.165(4) – fined of RM300 in default 3 days imprisonment • S.169(1) – fined of RM3,000 in default 2 weeks imprisonment
2. Syarikat Good Decade Sdn Bhd	<ul style="list-style-type: none"> • S.143(1) – fined of RM500 • S.165(4) – fined of RM300

Liaw Yen Ha, Ho Kam Leong and the company were represented by counsel Mohd Ikhwan whilst Steve Chin prosecuted prosecuting officer from SSM prosecuted on behalf of the Public Prosecutor.

SSM hopes the sentence meted out by the court serves as a reminder to the companies and its officers to comply with requirements of the Companies Act 1965.

SSM MEMPEROLEHI SABITAN TERHADAP PENGARAH-PENGARAH SYARIKAT GOOD DECADE SDN. BHD. BAGI KESALAHAN KETIDAKPATUHAN DI BAWAH AKTA SYARIKAT 1965

Pengarah-pengarah syarikat Good Decade Sdn. Bhd. iaitu Liaw Yen Ha dan Ho Kam Leong @ Hoo Yen Pat telah mengaku salah di Mahkamah Sesyen Kuala Lumpur pada hari ini bagi pertuduhan-pertuduhan di bawah seksyen 143(1), seksyen 165(4), dan seksyen 169(1) Akta Syarikat 1965.

Sewaktu prosiding yang sama, pengarah Ho Kam Leong @ Hoo Yen Pat juga telah membuat pengakuan salah bagi pihak syarikat Good Decade Sdn Bhd kerana melanggar peruntukan seksyen 143(1) dan seksyen 165(4) Akta Syarikat 1965.

Hakim Mahkamah Sesyen Kuala Lumpur, Puan Rihaida Rafei telah menjatuhkan hukuman denda seperti berikut:

1. Liaw Yen Ha Ho Kam Leong	<ul style="list-style-type: none"> • S.143(1) – denda RM500 jika gagal bayar 7 hari penjara • S.165(4) – denda RM300 jika gagal bayar 3 hari penjara • S.169(1) – denda RM3,000 jika gagal bayar 2 minggu penjara
2. Syarikat Good Decade Sdn Bhd	<ul style="list-style-type: none"> • S.143(1) – denda RM500 • S.165(4) – denda RM300

Liaw Yen Ha, Ho Kam Leong dan syarikat Good Decade Sdn Bhd diwakili oleh peguambela Encik Mohd Ikhwan. Manakala pendakwaan dijalankan oleh pegawai pendakwa Suruhanjaya Syarikat Malaysia ('SSM') Encik Steve Chin.

Kegagalan mematuhi kehendak asas Akta Syarikat 1965 adalah satu pelanggaran undang-undang yang dipandang serius oleh SSM. Tindakan penguatkuasaan yang diambil oleh SSM ini diharapkan dapat memberi peringatan kepada syarikat dan pegawai-pegawai syarikat agar sentiasa mematuhi Akta Syarikat 1965.
